


Operating buildings Energy for heating

Energy specifically for **heating residential buildings** is a huge part

Single **largest operating expenditure** for any building owner

Due to inefficient and poorly controlled buildings a **huge part** is **wasted**


Approximate total energy consumption



Operating buildings Fundamental flaws in the system - Misalignment

There is a **static misalignment** between the required energy and the actual used energy for heating a building

Leads to oscillating indoor temperatures and a **systemic waste** of energy





Operating buildings Fundamental flaws in the system – Imbalance


There is an **imbalance** in the hydronic distribution system. Some apartments are cold while some are hot

Forces the landlord to maintain a **higher indoor temperature** than necessary

Hence more **systemic waste** of energy

Diagnoses and corrects the misalignment by analyzing large amounts of data.




